### 5. Committee Reports:

#### a. ESCAPE - Carrie Hale and Spenser Moreland

- i. A special thank you to Karon Avery for her service to make ESCAPE happen.
- ii. This year's attendance stats are as follows:

  - b. 137 participants
  - c. 6 members from NM SAR Review Board
  - d. 3 vendors
  - e. 22 guests joining SAR volunteer registrants.
- iii. We will continue to offer the Day Pass for next year's event based on the success from this year.
- iv. The following stats are team attendance:
  - 1. OMTRS brought 17 members
  - 2. Santa Fe SAR 16 members
  - 3. Cibola SAR and Socorro SAR 12 members each
- v. Silent Auction will be closing at 7:00
- vi. We have three vendors this year: Search Gear, Conterra Inc, Durango Safety and Rescue
- vii. There are several static displays and Howard Paul of NASAR will have a table for volunteers to stop by and say hello.

### b. Speaker's Bureau – Larry Zentner

- i. Larry explained the intent of the Speaker's Bureau and invited the assembly to offer their trainings to other teams in the State.
- ii. Any 'Guest Speakers' who have a training they would like to offer are encouraged to contact Larry in order to broker trainings.

## c. Training Report - Spenser Moreland on behalf of Lloyd Voights

- i. Spenser provided information regarding the numbers of people who have completed trainings in 2013, highlighting the number of new members in the SAR community.

#### d. Public Information Officer - Carrie Hale

- i. Carrie recognized Dave Baldridge for his help in making press releases happen.
- ii. It was noted the importance of public information for the SAR Community in order to increase awareness of the Teams as a community resource. This increases membership inquiries as well as awareness for the financial needs these teams have in the state.
- iii. The council encourages teams to take advantage of the PIO to promote Trainings, Fundraisers and Mission reports

## e. Communications Committee - Bill Boedeker

- i. Bill presented a report from the Communications Committee.
- ii. The specified members of the committee are Don Hinson (Chairman), Bill Boedeker, Tom Bemis, Lloyd Voights, and Glenn Mauger.
- iii. The Committee wants to formalize the communications aspect of Search and Rescue

- iii. Due to the lack of personnel and time constraints the Los Alamos Civil Defense SAR organization has chosen to not continue participation at this time.
- iv. Richard Browning shared paperwork regarding the program to share with interested parties to get an idea of time and effort required.

## i. NM SAR Review Board representative - Bob Baker

- i. Bob explained the purpose of the NM SAR Review Board as well as his position on the board. He also detailed the members of the Board as well as their backgrounds.
- ii. Mr. Baker mentioned the revisions of the SAR Plan and thanked the membership for their input.
- iii. The final revisions of the SAR Plan will be distributed in the coming weeks. There will be a three-week comment period.
- iv. DET 1 from Alamogordo was approved on 25 April 2014 by the SAR Review Board. This team will be listed in the Resource Directory.
- v. The Review Board will be looking into the criteria of eligible SAR teams.
- vi. Insurance for equipment is in the process of being investigated by Major Armijo
- vii. The next SAR Review board meeting will be in Albuquerque on July 25<sup>th</sup>, 2014.

The proposed change was due to the chronic resignations over the past six years of Board Members not fulfilling their term requirements. An email was sent a month prior to this meeting for member team Officers to discuss. The Board Member interested in continuing for a second term

would need to go through the same voting process and either be nominated or submit a letter/SAR resume of interest.
