




FY 2016 NMSAR Council Overall Income vs. Expense Transaction Summary








#### FY 2016 ESCAPE Overall Income vs. Expense Transaction Summary



# Training

First priorities.

New Mexico allocates a certain amount of money every year for SAR training.

NMSARC and DPS are currently working to develop an appropriate system to process team-submitted requests for training funds.

We are also examining the most responsible way to allocate these funds.

For the moment it is a work in progress, however, I hope to have this process worked out ahead of the 2018 fiscal year.



### New Business: Proposed Bylaws Revision

Area	Change	Rationale
Signatories	Prior: Signatories for Council financial accounts shall be Chair, Vice-Chair, Secretary and Treasurer New: Signatories for Council financial accounts shall consist of the Chair, Vice-Chair, Secretary, ESCAPE Chair, and Treasurer as a minimum; more board members may be added as required	ESCAPE Chair is added to allow for greater flexibility and convenience when paying ESCAPE expenses
Number of signatures on checks	Prior: Any check over \$1,000 requires two signatures New: Only one signature is required for banking, checking, and savings account signature card authorizations.	The requirement for two signatures is logistically difficult with Board members spread across the state
Number of Board members required to approve spending of funds	Prior: Any check over \$1,000 requires two signatures New: Any transaction amount below \$1,000.00 requires approval of one board member as a minimum. Any transaction amount at or over \$1,000.00 requires approval of two board members as a minimum	The change helps to ensure oversight of large expenditures even though only one signature would be required.

## New Business: Membership Dues

#### **NMSARC** Membership Dues Adjustment Proposal

• In Summary: Our current operating expenses are exceeding our member annual dues income by several hundred dollars per year.

*Expenses include*: our mailbox, storage facility, mapping program maintenance, virtual meeting capabilities, supplies, and website fees.

• In addition, the current dues structure is highly regressive with large teams paying far less than small teams.

*Example:* A team of 11 members pays \$4.55 per member (\$50/year) while a team of 51 members pays \$1.47 per member (\$75/year).

Adjusting the membership categories based on team size would even out the cost across teams and increase council revenue by approximately \$500 per year.

If applied, 45% of teams would not see a significant change, and 47% of teams would incur an increase ranging from 40% to 100% with most at the lower percentile.

## New Business: Proposed Forum Guidelines

#### Background

- The NMSAR Forum (email list) has been in use for many years without "official" usage guidelines.
- Questions are raised periodically about appropriate use.
- The NMSARC Board has approved a draft set of guidelines for team consideration.
- If affirmed, official roll out of the guidelines would occur after this meeting.



### New Business: Forum Guidelines Summary

- Purpose of the Forum (...for discussion of topics of interest to the NM SAR community.)
- Forum Membership (i.e., Any member of a NMSARC member team is eligible to join. Other individuals may request membership and will be considered on a case-by-case basis.)
- Rules of the Road (a few samples shown below)
  - All posts must relate directly to search and rescue.
  - Be civil. Posts that are deliberately hostile or insulting to other members of the NMSAR Forum community will be removed and a warning sent to the posting party.
  - Do not advertise. You may post information about a product or service (e.g., fee-based training(s)) that are related to search and rescue.
  - Do not solicit personal information.
  - Include your name in all posts. Including your team affiliation is also recommended.
  - If you are unsure whether your post fits these guidelines, please send your request to <u>admin@nmsar.org</u>.
- Inappropriate Use (...A post may be removed by Board action and the person posting will be issued a warning. A second violation will result in permanent revocation of the individual's Forum privileges.
