I. Call to Order: Phyllis called the meeting to order at 5:45 PM

<u>II.</u> Minutes from last meeting: Bob moves to approve last meeting's minutes. 2^{nd} by Nate. Unanimously approved.

III. Treasurer's Report: There is \$16276.03 in ESCAPE account; ING Direct account has \$5278.52; NMESC account has \$1915.66; Savings has \$1808.87. Nate moves to accept Treasurer's report. 2nd by Tom. Unanimously approved.

IV. Committee Reports

A. Training Reports: Philmont training was successful.. There were 25 participants. Responses and feedback were largely positive; one suggestion was to spend more time to get to know other participants. Other feedback stated it would be helpful to have more hand-on practice. Unfortunately, there was not very much snow at the time of the training. Upcoming trainings include a Navigation Training March 12th in Las Cruces, Riverbank Training April 16th in Albuquerque, and ESCAPE in May. In August there will be a large mock search in ABQ. Brian in working with Tony Gaier from Cibola SAR on this mock search. This training will involve all aspects of search including technical, K9s, etc, plus practice in the changing of an Operational Period. In the future there will be training on plant identification. There is discussion of a potential Field Certification Trainings prior to some of the exam opportunities.

B. ESCAPE Report: The Keynote Speaker at ESCAPE is Secretary Gorden E. Eden, Secretary of the Department of Public Safety in New Mexico. There is a horse policy in place now for ESCAPE. John shared the following ESCAPE forms for approval: Registration, Horse policy/requirements, Canine policy/requirements, Training Schedule, Track leads, Invitations for the Governor, Suzanna Martinez, Mike Valverde, Resource Officer, and the new State Police Chief. We are still seeking sponsors and vendors. John is asking each Board member to ask local businesses to donate food, supplies and contribution to the silent auction. We are also looking for a radio vendor. Nate will contact all previous sponsors from ESCAPE to ask for assistance. Brian volunteered to check with National Guard to get a climbing wall for ESCAPE. There will be a need to buy a plaque for the Ralph Dawdy award. A lunch and dinner will be provided at ESCAPE—details are still in the planning stages. A mission number and IC and all SC positions have been assigned. Phyllis asks each Board member to please contact Liaison teams and invite them personally to ESCAPE. Phyllis will invite other state agencies, including BLM, Park Service, Forest Service, CAP, EMS, Mountain Rescue Association, etc. Press releases are ready, and Pat will send them in timely manner.

- C. Membership Report: 22 teams have renewed their membership out of 41 teams. Mailings were delayed by the expectation that teams would respond to the electronic application package. Brian has now mailed explanations and packages to teams that have not completed their applications. He plans to follow up with phone calls. After that time, the Board will be asked to contact their Liaison teams to encourage them to submit their renewals.
- **D.** Newsletter / Public Relations: Pat has completed the Newsletter, and it is on the website. A quarterly newsletter is the goal. The next Newsletter will be published at the end of March. Pat encourages people to send photos for the newsletter. Training page is popular and will be continued.
- **E. Training Directory:** David will send out invitations for members to volunteer as trainers via the training directory. We will advertise it in the newsletter and at ESCAPE.
- **F. Website**: Pat has volunteered to be responsible to make sure that all names, documents, etc. are consistent with names on the website. It is proposed that acronyms that are used for search and rescue be defined on the web.
- **G. Fundraising: Progress Reports:** Nate reports that he is following up on door prizes and is still working to find ways to raise funds for the Council. The board will give him suggestions for possible sponsors in their communities.
- **H. Field Certification Report:** There was discussion about having a six hour training offered a few times a year prior to Field Certification Exams. This may help with new teams, especially. The program for

providing Field Certification Exams is very aggressive and continues to offer opportunities. We have 12-15 new evaluators.

- I. SAR Review Board/Future: There has not been a meeting since December, 2010. We have plans to contact the Governor's office to request
